
WHEREAS, the Council of The City of San Diego has enacted the Community Plan Implementation Overlay Zone ordinance; and

WHEREAS, ministerial review by the Planning Director shall be required for Type A permit application; and

WHEREAS, discretionary review by the Planning Director shall be required for all projects that do not meet the requirements of the underlying zone or for Type B permit application; NOW, THEREFOR,

BE IT RESOLVED, by the Council of The City of San Diego, that as permitted by Section 101.0204 of the Municipal Code, the establishment of a fee of \$500.00 for processing a Community Plan Implementation Overlay Zone Type A permit application, and a deposit of \$1,500.00 for processing a Community Plan Implementation Overlay Zone Type B permit application be, and the same is hereby authorized and approved.
