ADOPTED ON JUN 17 1986

WHEREAS, Navy Captain Pete Litrenta was assigned to San Diego in September 1984 as Public Affairs Officers, Commander Naval Base; and

WHEREAS, Captain Litrenta set about immediately to cement the amicable relations between San Diego and the military communities; and

WHEREAS, Captain Litrenta's enthusiasm for San Diego civic projects resulted in close cooperation between military and civilian authorities; and

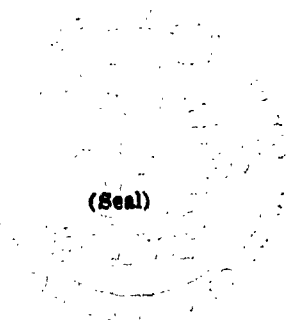
