

RESOLUTION NUMBER R- 266025

ADOPTED ON JUN 17 1986

A RESOLUTION AMENDING THE TIERRASANTA
COMMUNITY PLAN TO REFLECT THEREIN THE ADOPTED
ALIGNMENT OF STATE ROUTE 52.

WHEREAS, the TIERRASANTA COMMUNITY PLAN was adopted by the
City Council on July 27, 1982, under Resolution No. 256890; and

WHEREAS, the northerly boundary of that plan was defined with
reference to the future alignment of proposed State Route 52, and
urban land use designations were applied to the lands southerly
of the "corridor" alignment shown on the community plan map at
that time; and

WHEREAS, the community plan text indicates that both the
northerly boundary of the planning area and the urban land use
designations are intended to extent to the future right-of-way of
State Route 52; and

WHEREAS, a precise alignment of State Route 52 has
subsequently been adopted by the State of California; and

WHEREAS, it is desirable to amend the community plan to
recognize the presently adopted alignment of State Route 52 and
the resulting land use designations so that the projected usage
of these lands may be readily determinable; and

WHEREAS, the Planning Commission and the Council of The City
of San Diego held public hearings on May 29, 1986 (continued to
June 5, 1986) June 17, 1986, respectively, to consider amending
the TIERRASANTA COMMUNITY PLAN; and

WHEREAS, on June 5, 1986, the Planning Commission adopted Resolution No. 6341, thereby approving and recommending that the Council of The City of San Diego adopt the proposed amendment; and

WHEREAS, the proposed amendment of the TIERRASANTA COMMUNITY PLAN will not become effective until adopted by the Council; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council hereby approves the amendment of the TIERRASANTA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 266025, to reflect therein the adopted alignment of State Route 52 and the resulting land use designations as illustrated in Planning Department Report No. 86-357.

2. That the amendment of the TIERRASANTA COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans at the next scheduled omnibus hearing.
