

RESOLUTION NUMBER R- 266026

ADOPTED ON JUN 17 1986

A RESOLUTION AMENDING THE PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO TO REFLECT THEREIN THE MIDWAY COMMUNITY PLAN, OTAY MESA-NESTOR COMMUNITY PLAN, SAN YSIDRO COMMUNITY PLAN, SERRA MESA COMMUNITY PLAN, SOUTHEAST SAN DIEGO COMMUNITY PLAN, TIERRASANTA COMMUNITY PLAN, UNIVERSITY COMMUNITY PLAN, AND UPTOWN COMMUNITY PLAN.

WHEREAS, California Government Code Sections 65350 through 65362 set forth State requirements for the preparation, adoption and amendment of local general plans; and

WHEREAS, said State law and City Council Policy 600-7 require that consistency be maintained among the City's general plan and the various community plans and other official planning-related documents, subject to the limitation on the frequency of amendments to mandatory elements of the general plan; and

WHEREAS, within the period October 1, 1985 to April 1, 1986, and on June 17, 1986 the Council of The City of San Diego has approved the following:

1. Midway Community Plan amended December 3, 1985 by Council Resolution No. 264615; associated EMND-85-0632 certified by Resolution No. 264614.
2. Midway Community Plan amended March 11, 1986, by Council Resolution No. 265231; associated EMND-85-0633 and END-85-0699 certified by Resolution No. 865230.
3. Otay Mesa-Nestor Community Plan amended November 26, 1985 by Council Resolution No. 264562; associated EMND-85-0256 and its Addendum 85-0683 certified by Resolution No. 264559.

4. Otay Mesa-Nestor Community Plan amended March 17, 1986 by Council Resolution No. 265259; associated EMND-85-0170 certified by Resolution No. 265258.

5. San Ysidro Community Plan amended November 19, 1985 by Council Resolution No. 264488; associated END-85-0108 certified by Resolution No. 264487.

6. Serra Mesa Community Plan amended June 17, 1986 by Council Resolution No. ~~265024~~ exempt from CEQA.

7. Southeast San Diego Community Plan amended April 1, 1986 by Council Resolution No. 265347; associated EIR-84-0721 and the Addendum thereto certified by Resolution No. 265346.

8. Tierrasanta Community Plan amended June 17, 1986 by Council Resolution No. ~~265025~~ exempt from CEQA.

9. University Community Plan amended November 26, 1985 by Council Resolution No. 264552; associated END-85-0446 certified by Resolution No. 264551.

10. Uptown Community Plan amended November 26, 1985 by Council Resolution No. 264570; exempt from CEQA; and

WHEREAS, the Planning Commission and the Council of The City of San Diego held public hearings on May 29, 1986 (continued to June 5, 1986) and June 17, 1986, respectively, to consider amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO to reflect those plans noted above; and

WHEREAS, the Planning Commission on May 29, 1986 and June 5, 1986 adopted Resolutions No. 6332, 6340, and 6341, thereby approving and recommending that the Council of The City of San Diego adopt the proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO will not become effective until adopted by the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said amendments to the GENERAL PLAN MAP of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO be, and the same are hereby adopted.
