WHEREAS, Mr. Moore is now moving on to accept new challenges in private industry; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Patrick W. Moore be and he is hereby commended for efforts to improve the economic conditions of unemployed and disadvantaged San Diegans, thereby lessening governmental costs and improving the overall economy of San Diego.
