## RESOLUTION NUMBER R- 266042 ADOPTED ON JUN 23 1986

WHEREAS, section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where a street has been superseded by relocation and where a portion of the street is excess right-of-way no longer needed for street or highway purposes; and

WHEREAS, the abutting property owners have requested the vacation of Miramar Road and a portion of Eastgate Mall in conjunction with the Nexus Technology Centre Subdivision

(T.M. 85-0446) to facilitate development of their properties; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Miramar Road and a portion of Eastgate Mall, as more particularly shown on Drawing No. 16691-B on file in the office of the City Clerk as Document No. RR-265942-1, which is by

this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until the final subdivision map for Nexus Technology Centre (T.M. 85-0446) has been approved by Council action. In the event that the final subdivision map is not approved by January 15, 1992, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.




