BE IT RESOLVED, by the Council of The City of San Diego, that a 20-foot-wide sewer easement, being a portion of Section 28, Township 18 South, Range 1 West, San Bernardino Base and Meridian, located adjacent to the north side of Otay Mesa Road on Brown Field Airport property, and as more particularly described in the legal description attached hereto, is hereby set aside for the construction of the Otay Valley Trunk Sewer Project.

BE IT FURTHER RESOLVED, that the transfer of an amount not to exceed \$24,950, which is the appraised value of the easement, from Fund 39012, Object Account 4939, Job Order 260279, to Airports Capital Outlay Fund 30250, Revenue Account 78336, is hereby authorized and approved.


