
RESOLUTION NUMBER R- 266051

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, effective between the hours of 8:00 a.m. and 6:00 p.m., Saturdays, Sundays and certain holidays excepted, be and the same is hereby established on the north and south sides of Beech Street from Pacific Highway east to the railroad tracks.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
