WHEREAS, on January 7, 1985, by Resolution No. R-262292 (copy attached hereto as Exhibit A), this City Council declared the residential premises at 6365 Shaules Avenue, a public nuisance and authorized its abatement; and

WHEREAS, on September 12, 1985, the structure was destroyed by fire leaving only a few severely charred support elements;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to administratively abate by demolition the residential premises located at 6365 Shaules Avenue, which was declared a nuisance by Resolution No. R-262292.

BE IT FURTHER RESOLVED, that an amount not to exceed \$2,600.00 from the Building Inspection Enterprise Fund (Fund 41300, Dept. 1300, Org. 3510, Acct. 4222, J.O. 006301) is hereby authorized to be expended for such demolition work.

BE IT FURTHER RESOLVED, that a record of the cost of all such work performed shall be transmitted to the City Council, which shall consider the same to be paid and levied as a special assessment against the property.

BE IT FURTHER RESOLVED, that the City Attorney is authorized and instructed to take appropriate legal action to abate the aforesaid nuisance.


