RESOLUTION NUMBER R- 266081

ADOPTED ON JUN 24 1986

WHEREAS, through the adoption of Ordinance Nos. O-15174 N.S. adopted January 28, 1980 and O-15614 N.S. adopted November 16, 1981, the City Council has given the San Diego Fire Department the authority to inspect private properties and to cause owners to cleanup and remove overgrown weeds, grass, brush and/or rubbish and combustible waste; and

WHEREAS, Fire Department personnel have completed the inspection phase of the 1986 program and have notified affected owners of the existence of hazardous weed and rubbish conditions on their properties; and

WHEREAS, sufficient time and notification have been given to the affected owners between March 11, 1986 and May 12, 1986, to successfully perform cleanup operations on said properties; and

WHEREAS, an appeals hearing was held on June 4, 1986 to allow owners to appeal any aspects of the program they felt were not proper; and


WHEREAS, the 1986 program inspected 3,500 properties for violations of the City Weed Abatement Ordinance and it is estimated that approximately 250 parcels will require abatement by the City; and

WHEREAS, those properties where hazards continue to exist can be abated providing the City Council adopts a resolution declaring such properties public nuisances and orders the properties to be abated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that all of those properties listed in Attachment "A," on file in the office of the City Clerk as Document No. RR- 266081 , not in compliance with City Weed and Rubbish Abatement Ordinance No. 0-15174 N.S. are hereby declared to be public nuisances and the same are ordered to be abated pursuant to the provisions of law.
