WHEREAS, P AND G COMPANY, a California corporation, and LOMAS SANTA FE, INC., a California corporation, have requested an exchange of drainage easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance by the City Manager of those deeds of P AND G COMPANY and LOMAS SANTA FE, INC., executed in favor of The City of San Diego, bearing date of September 13, 1985, and September 12, 1985, respectively, conveying to said City a drainage easement in a portion of Lot "K," Map 11431, and in a portion of Lot 2, Map 6737, as more particularly described in said deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR- 266082/and RR- 266082¹ is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 266082³, quitclaiming to P AND G COMPANY and LOMA SANTA FE, INC. all of the City's right, title and interest in the drainage easement in a portion of Lot "K," Map 11431, in a portion of Lot 5, Map 8646, and in a portion of Lot 2, Map 6737, as more particularly described in said deeds.

3. That the City Clerk is hereby authorized and directed to deliver the deeds, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
