WHEREAS, it is now appropriate to forward the matter to the full Council for necessary action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation contained in Planning Department Report No. 86-371, dated June 11, 1986, to endorse the updated Regional Transportation Plan and support its adoption, be and the same is hereby adopted and approved.
