
ADOPTED ON JUN 24 1986

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Capital Improvement Program of the Sewer Utility Revenue Fund No. 41506 is hereby amended by adding CIP No. 46-125.0, Via de la Valle Sewer System.
2. That the cash contribution in the amount of \$46,990 from Rancho Santa Fe Plaza for the purpose of purchasing 40 EDU's of capacity in the proposed Assessment District No. 4006, Via de la Valle Sewer System is hereby accepted.
3. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$176,761 within the Sewerage Utility Revenue Fund No. 41506 from the Unallocated Reserve Fund No. 70697 to the Wastewater Systems Construction Program Fund 70492, CIP No. 46-125.0, Via de la Valle Sewer System.
4. That the expenditure of an amount not to exceed \$176,761 from the Sewerage Utility Revenue Fund No. 41506, CIP No. 46-125.0, Via de la Valle Sewer System, is hereby authorized,

solely and exclusively for the purpose of making a contribution
to the proposed Assessment District No. 4006, Via de la Valle
Sewer System Assessment District.
