

RESOLUTION No. R-266095

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL MODIFICATIONS AND INTERCONNECT ON MIRA MESA BLVD., ON CAMINO RUIZ AND CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT MIRA MESA BLVD. AND WESTMORE ROAD/ MARBURY AVENUE, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on JUN 30 1986 and bearing official Document No. 440. 118596 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL MODIFICATIONS AND INTERCONNECT ON MIRA MESA BLVD., ON CAMINO RUIZ AND CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT MIRA MESA BLVD. AND WESTMORE ROAD/MARBURY AVENUE.
4. That the City Auditor and Comptroller is hereby authorized to transfer \$170,534 (\$90,000 from Capital Outlay Fund 30245 CIP No. 61-001 ANNUAL ALLOCATION - SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN TRAFFIC CHANGES and \$80,534 from Revenue Sharing Fund 18013 CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS) to CIP No. 62-257 MIRA MESA BOULEVARD MASTER TRAFFIC CONTROL SYSTEM.
5. That the expenditure, not to exceed \$301,117 (\$90,000 from Capital Outlay Fund 30245, \$130,583 from Gas Tax Fund 30219, and \$80,534 from Revenue Sharing Fund 18013) from CIP No. 62-257 MIRA MESA BOULEVARD MASTER TRAFFIC CONTROL SYSTEM is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

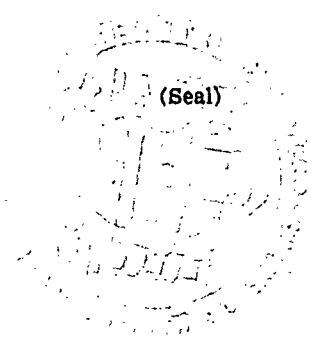
