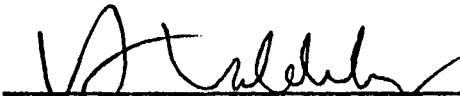
RESOLUTION NUMBER R- 266100

ADOPTED ON JUN 30 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those street easement deeds of BERNARDO REGENCY CENTRE, LTD., a California limited partnership, and THE MONTADURA, a joint venture, executed in favor of The City of San Diego, bearing dates of February 24, 1986, and February 20, 1986, respectively, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 266100-1 and RR- 266100-2, granting to said City an easement for public street purposes in Parcel 1 of Parcel Map No. 13778, and in a portion of Lot 8 of Bernardo Industrial Park North, Map No. 9570, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named WEST BERNARDO COURT.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
