RESOLUTION NUMBER R-266136 ADOPTED ON JUNE 30, 1986

WHEREAS, the California Outer Continental Shelf (OCS) Local Government Coordination Program (LGCP) originated in 1979 to enable local jurisdictions along the California coastline to keep up to date on federal OCS oil and gas leasing plans; and

WHEREAS, the program director is Richard Charter, who maintains an office in Sonoma County; and

WHEREAS, program activities include providing information to local agencies regarding the Department of Interior planning process and educating boards and councils about OCS leasing implications and to date, the focus of the program has been on northern California; and

WHEREAS, primary activities are information sharing, press relations, and lobbying; and

WHEREAS, the Director of Intergovernmental Relations recommended, in his Report No. 86-35 to the Rules Committee, that the City subscribe to the OCS Action Alert newsletter published by Richard Charter, at an annual subscription fee of \$250; and

WHEREAS, it was further recommended that the Council designate an official City contract for the OCS Local Government Coordination Program; and

WHEREAS, the Rules Committee considered said recommendations and approved them unanimously; and

WHEREAS, in the discussion contained in IRD Report No. 86-35, it was stated that Mr. Charter directs an OCS Local Government Coordination Program (LGCP) under contractual arrangements with the County of Santa Cruz; and

WHEREAS, provision exists under the LGCP for other municipal participants (i.e., City of San Diego) to "buy in" on the aforementioned agreement for the sum of \$2,000 and derive all the contractual benefits therefrom; and

WHEREAS, on June 30, 1986, the Council directed that such "buy in" action be pursued for fiscal year 1987 at the cost of \$2,000; and

WHEREAS, it is now necessary to authorize the execution of an "Acceptance of Consultant Services Agreement" which effectively makes The City of San Diego a recipient of Mr. Charter's services with the County of Santa Cruz under that same LGCP Consultant Services Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an ACCEPTANCE OF CONSULTANT SERVICES AGREEMENT, pursuant to the terms and provisions of that certain Consultant Services Agreement between the County of Santa Cruz and Richard A. Charter, and attached thereto as Exhibit A, a copy of which is on file in the office of the City Clerk as Document No. RR-266136

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$2,000 as a one-year membership fee for The City of San Diego in the above

authorized agreement, for fiscal year 1987, in order that the City can participate in the statewide networking system regarding offshore drilling.

BE IT FURTHER RESOLVED, that Environmental Quality Division of the Planning Department be and it is hereby designated as the City's official contact for purposes of the OCS Local Government Coordination Program.
