RESOLUTION NUMBER R- 266137

ADOPTED ON JUN 30 1986

WHEREAS, government grants now represent about 9% of the City's total budget; and

WHEREAS, there is no provision for a systematic review by the City Council of grant applications prior to a City department's request for approval; and

WHEREAS, the Intergovernmental Relations Department, in its IRD Report No. 86-31, dated June 10, 1986, recommends that regular briefings be provided by a requesting department to its designated Council Committee regarding grant applications, when more than one City activity, project or site would benefit from the funding source, so that Council review can occur earlier in the grant application process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation set forth in IRD Report No. 86-31, dated June 10, 1986 relating to Council briefings regarding grant applications be and it is hereby endorsed in concept.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to review this recommendation and prepare to implement it early in FY 1987.
