RESOLUTION NUMBER R- 266143

ADOPTED ON JUN 30 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of that street, sewer and drainage easement deed of SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, dated April 1, 1986; and those street, sewer and drainage easements and abutters' rights of access deeds of PACIFIC CORPORATE ASSOCIATES-II, a California limited partnership, dated February 26, 1986, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 266143 -1, RR- 266143 -2, RR- 266143 -3 and RR- 266143 -4, granting to said City easements for public street, sewer and drainage purposes in a portion of Lot 1, Section 4, Township 15 South, Range 3 West, San Bernardino Meridian, and in a portion of Parcel 1 and Parcel 4 of Parcel Map No. 13841, and abutters' rights of access relinquished in and to Mira Mesa Boulevard, adjacent and contiguous to portion of Parcel 1 of Parcel Map No. 13841, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same are hereby named BARNES CANYON ROAD, PACIFIC CENTER BOULEVARD, MIRA MESA BOULEVARD and PACIFIC MESA BOULEVARD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
