
RESOLUTION NUMBER R- 266158



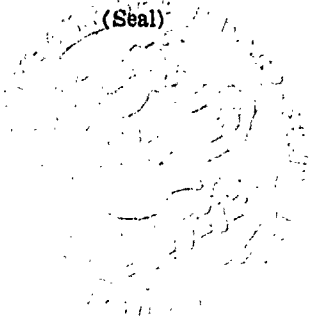
