


RESOLUTION No. R- 266165 (R-86-2399)

Adopted on JUL 07 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT EADS AVENUE AND PEARL STREET, AND AT GILMAN DRIVE AND VILLA LA JOLLA DRIVE, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on JUL 07 1986 and bearing official Document No. W.O. 118763 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT EADS AVENUE AND PEARL STREET, AND AT GILMAN DRIVE AND VILLA LA JOLLA DRIVE.
4. That the expenditure, not to exceed \$153,000 from CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS (\$63,000 from Revenue Sharing Fund 18014 and \$90,000 from Facilities Benefit Assessment Fund 79001) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
