
RESOLUTION NUMBER R- 266168

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the partial closure of the alley east of Herschel Avenue and south of Kline Street, as described in Exhibit "A" attached, adjacent to Stella - Maris Academy to motor vehicle traffic to allow its use by the adjacent property owner.

BE IT FURTHER RESOLVED, that The City Council acting under the authority of California Vehicle Code section 21101(a) finds that this portion of the alley is not currently needed for motor vehicle travel.
