


RESOLUTION NUMBER R- 266170

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to LAKESIDE SANITATION DISTRICT an easement for public sewer mains affecting a portion of City-owned land, being a portion of El Cajon Valley Company's Lands, Map No. 289, located adjacent to Moreno Avenue between San Vincente Avenue and Willow Road in Lakeside, as more particularly described in that deed on file in the office of the City Clerk as Document No. RR- 266170
