ADOPTED ON JUL 07 1986

WHEREAS, HR 1 extends federally assisted housing programs;
and

WHEREAS, earlier HUD issued regulations required
documentation from existing and prospective tenants of federally
assisted housing, indicating their legal status; and

WHEREAS, in San Diego, the Housing Commission would have had
to review the status of approximately 30,000 individuals; and

WHEREAS, there are concerns over costs of staff time, legal
costs, and for families which may not be able to produce such
documentation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that
this Council supports an amendment to HR 1 which would require
citizenship documentation only for prospective tenants of
federally assisted housing.
