WHEREAS, on August 12, 1985, an agreement was executed between the City and Industrial Medical Centers to provide preemployment physical examinations and other medical services for fiscal year 1986; and

WHEREAS, because of increased hiring of Police Recruits, the implementation of a preemployment drug screening program in September 1985, and conservative fiscal projects when the budget was prepared, the original amount budgeted for this purpose was too low; and

WHEREAS, it is now necessary to provide for such adjustment and authorize the additional anticipated expenditure of \$49,000 to the Industrial Medical Centers, for the purpose of providing such additional preemployment physical examinations and other medical services as have been required; and

WHEREAS, this additional expenditure is in addition to that authorized originally by Resolution No. R-263841 on August 12, 1985; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to expend, upon proper request and documentation, an additional anticipated amount up to \$49,000, for preemployment physical examinations and other medical services, to the Industrial Medical Centers, pursuant to the executed agreement approved by Resolution No. R-263841 on August 12, 1985.
