WHEREAS, the services and costs thereof are set forth in the agreement approved by Council on August 12, 1985 by Resolution No. R-263841 and on file in the office of the City Clerk as Document No. RR-263841; and

WHEREAS, the term of said agreement expires on June 30, 1986; and

WHEREAS, it is desired to extend the term of said agreement for an additional year until June 30, 1987, under the same terms and conditions, to include a standardized Indemnification and Hold Harmless provision; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Personnel Director be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a FIRST AMENDMENT TO AGREEMENT, a copy of which is on file in the office of the City Clerk as Document No. RR- 266182 , between the City of San Diego and the Industrial Medical Centers, to extend for a period of one (1) year until June 30, 1987, the agreement to provide preemployment physical examinations and other additional medical services, under the same terms and conditions of the extended agreement on file in the office of the City Clerk as Document No. RR-263841.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend all necessary funds that are appropriated and allocated for said purposes.
