

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an interagency service agreement with the State of California Department of Transportation (CALTRANS), to provide specialized investigative equipment and an operator in connection with the investigation and analysis of a deteriorated girder in the West Mission Bay Drive bridge over Mission Bay Channel, under the terms and conditions set forth in the Interagency Service Agreement on file in the office of the City Clerk as Document No. RR-266206.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$9,570 from Fund No. 18013 CIP No. 91-801.3, General Revenue Sharing -General Contingency Fund to CIP No. 22-066.0, Rehabilitation of the West Mission Bay Drive Bridge Girder.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$9,570 from Fund 18013 CIP No. 22-066.0, Rehabilitation of the West Mission Bay Drive Bridge Girder, is hereby



authorized, solely and exclusively for the purpose of providing funds for the above project.
