- 4. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$25,000 from CIP No. 91-801.3, General Revenue Sharing General Contingency Fund, Fund No. 18013 to CIP No. 22-066.0, Rehabilitation of the West Mission Bay Drive Bridge Girder.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$25,000 from CIP No. 22-066.0, Rehabilitation of the West Mission Bay Drive Girder, Fund No. 18013, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project and related costs.
