

- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF POINT LOMA WASTEWATER TREATMENT PLANT--EXPANSION OF HEADWORKS AND GRIT REMOVAL FACILITIES, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on No. W.O. 147212 be, and the same are hereby approved.
- 2. That the Purchasing Agent of the City of San Diego be, he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- That the City Manager is hereby authorized to execute a con-3. tract with the lowest responsible bidder for CONSTRUCTION OF POINT LOMA WASTEWATER TREATMENT PLANT--EXPANSION OF HEAD-WORKS AND GRIT REMOVAL FACILITIES.
- That the expenditure, not to exceed \$5,072,796 from Sewer 4. Revenue Fund 41506, CIP No. 46-094 POINT LOMA - EXPANSION OF HEADWORKS AND GRIT REMOVAL FACILITIES, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
