RESOLUTION NUMBER R- 266224

ADOPTED ON JUL 14 1986

WHEREAS, the United States Men's and Women's Olympic Volleyball Team presently trains in San Diego; and

WHEREAS, the United States Olympic Committee has expressed an interest in finding a year-round warm weather site for the training of its athletes; and

WHEREAS, at Councilmember Gloria McColl's request, the Public Facilities and Recreation Committee directed the City Manager to contact the United States Olympic Committee and invite a representative to officially tour San Diego as a potential warm weather training site; and

WHEREAS, a representative of the United States Olympic Committee recently toured San Diego to look at possible sites for a training facility; and

WHEREAS, it is abundantly apparent that San Diego would be an excellent location for such training facility; and

WHEREAS, such a facility could provide opportunities for our local youth that some might not otherwise have; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby establish an Olympic Training Site Ad Hoc Task Force to consist of thirteen (13) members [including chairperson] for the purpose of:

1. Acting as the official liaison between the United States Olympic Committee and The City of San Diego, and

2. Evaluating possible sites for an Olympic Training Center, and reporting their findings and recommendations to the Public Facilities and Recreation Committee and the San Diego City Council.


BE IT FURTHER RESOLVED, that the City Council hereby appoints Councilmember Gloria McColl to serve as chairperson of said Task Force, with other members to be appointed by said chairperson to include, but not necessarily be limited to representatives from the following areas:

1. Members from the field of athletics.
2. Representatives of the Hotel Motel Association.
3. Representatives from the San Diego Convention and Visitors Bureau.
4. Representatives from the Greater San Diego Sports Association.
5. Representatives from the Greater San Diego Chamber of Commerce.
6. Representatives from the Community at Large.

BE IT FURTHER RESOLVED, that the City Manager and the Planning Director be and they are hereby directed to provide staff assistance to the Task Force as may be required and that

the City Attorney is requested to provide legal services as necessary.
