WHEREAS, the San Diego Narcotics Task Force participated in an investigation which has resulted in the forfeiture of a Bell Model 206 B helicopter to the government, said aircraft being currently located outside the State of California, and

WHEREAS, the above aircraft has become eligible for equitable transfer to the City of San Diego Police Department for law enforcement activities, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to accept, for and on behalf of said City, equitable transfer of a Bell Jet Ranger Model 206 B helicopter serial number 215.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to expend the amount of not more than \$3,190 from Special Fund 10132 solely and exclusively for the purpose of insuring the above aircraft for the remainder of calendar year 1986 and ferrying it to San Diego.
