ADOPTED ON JUL 15 1986

WHEREAS, as part of its FY 1987 negotiated benefits package, the City is providing the CITYHEALTH Wellness Program to its employees; and

WHEREAS, this program will provide health risk assessment and training to approximately 650 City employees; and

WHEREAS, the health risk assessment includes a basic health review by a preventive medicine nurse, blood chemistries analysis with a complete lipid profile, a body composition analysis (skinfold), blood pressure analysis and musculoskeletal evaluation; and

WHEREAS, training is to include a one-hour health profile feedback session with written nutritional and exercise guidelines tailored to the individual's results; and


WHEREAS, the twelve-hour training session includes topical treatment on the overviews of optimal health, stress awareness and stress management, practical nutrition, exercise and weight control, minimizing the risk of cancer and chemical dependency; and

WHEREAS, monies are available in the FY 1987 Budget in the Risk Management Department; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Sharp

Memorial Hospital to provide health risk assessment and training services to City employees, pursuant to the terms and conditions of the Health Risk Assessment and Training Agreement, on file in the office of the City Clerk as Document No. RR- 266230 .
