RESOLUTION NUMBER R- 266231

ADOPTED ON JUL 14 1986

WHEREAS, the California Police Olympics was founded in San Diego in 1967; and

WHEREAS, the 1987 World Police and Fire Games will be hosted by the San Diego Police Athletic Federation; and

WHEREAS, the Police Olympics has grown to the second largest athletic event in the world behind the International Olympic Games; and

WHEREAS, nearly 7,500 police and firefighters competitors from all fifty states, and twenty-five foreign countries will be represented; and

WHEREAS, the San Diego Police Athletic Federation has successfully hosted the Police Olympics in 1967, 1972, 1980, and 1983 and co-hosted the International Police Olympics in 1978; and

WHEREAS, it is anticipated that between 15,000 and 18,000 law enforcement and firefighter members and their families will attend these events in San Diego; and


WHEREAS, the Council acknowledges the importance of promoting athletics and physical fitness among members of law enforcement and firefighters; NOW, THEREFORE,
