- 3. That the City Manager be and he is hereby fully authorized, on behalf of The City of San Diego, to accept the sum of \$491,975 from Pardee Construction Company and cause said amount to be deposited to the account of CIP 52-382.
- 4. That the Auditor and Comptroller be and he is hereby fully authorized to expend the sum of \$2,000,000 from CIP 52-382 in furtherance and support of the condemnation action authorized by the City Council in this matter.
