ADOPTED ON JUL 21 1986

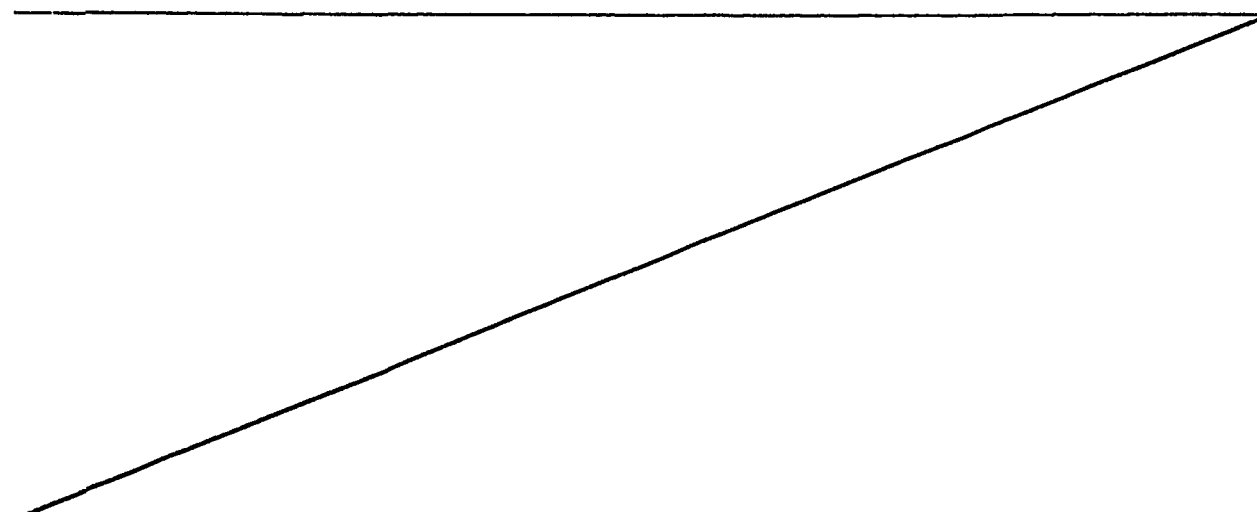
WHEREAS, the Father Junipero Serra Trail is a two-lane winding road which extends northeasterly from Mission Gorge Road through Mission Trails Regional Park to the City limit with Santee; and

WHEREAS, all lands along this road to the City limits are owned by The City of San Diego; and

WHEREAS, due to the remoteness of this area, numerous illegal activities (vandalism, shooting, dumping, etc.) are prevalent during hours of darkness, especially in the vicinity of the Old Mission Dam; and


WHEREAS, the Mission Trails Regional Park Task Force has recommended that the road be closed during hours of darkness; and

WHEREAS, night time closure of Father Junipero Serra Trail is also necessary to improve safety, by eliminating serious accidents occurring on this road during night time hours; NOW, THEREFORE,



BE IT RESOLVED, by the Council of The City of San Diego, that the closure of Father Junipero Serra Trail to vehicular traffic between Mission Gorge Road and the City of Santee City limits from Sunset to Sunrise be and the same is hereby authorized.
