That the Auditor and Comptroller be and he is hereby authorized to expend an amount not to exceed \$355,113 from the Human Care Services Special Fund (Fund 19629), to operate four social service programs and \$36,700 from Fund 18522 (Twelfth Year Community Development Block Grant Entitlement), to operate the Senior Emergency Alert System service program, under the agreement with the Clairemont Friendship Center, Inc., during fiscal year 1987.
