Mary Marino	Treasurers	\$242.32	Ms. Marino is a Data Entry Operator. She suggested designing a program to facilitate the entering of payee data into the Parking Citation system. This is expected to save \$1,615.44 in time. This is a partial award pending a 12-month review.
Dorothy Norris Eric Dalton	Utilities	\$233.87	Ms. Norris is a Biologist II and Mr. Dalton is a Lab Technician with the Metro Division. They suggested using a computer program to log information about lab samples. This is expected to save \$2,003.22 in time. This is a partial award pending a 12-month review.

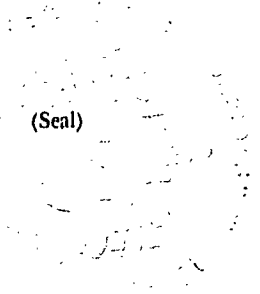

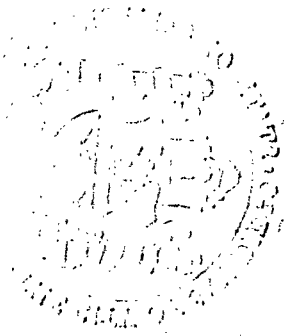
