


RESOLUTION No. R- 266283 (R- 87-17)

Adopted on JUL 28 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of PINKERTON'S, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SECURITY GUARD SERVICE AT THE SAN DIEGO JACK MURPHY STADIUM as may be required for a period of one (1) year beginning September 1, 1986 through August 31, 1987, at a cost of \$6.54 per hour regular time and \$8.99 per hour for holidays, for a total estimated cost of \$80,886.72; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods with a price escalation not to exceed 4% of prices in effect at the end of each prior year.
2. That a contingency contract is hereby authorized with LOCATOR SERVICES, INC., the second ranked bidder, per prices on file in the Purchasing Department, in the event the primary contractor fails to provide service in accordance with specifications.
