

RESOLUTION NUMBER R- 266289

ADOPTED ON JUL 28 1986

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the acceptance by the City Manager of a sewer easement deed of WESTERN SALT COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of May 16, 1986, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 266289 - 1, granting to said City a sewer easement in portions of Sections 20 and 21, Township 18 South, Range 2 West, SBBM, as more particularly described in said deed, be, and the same is hereby approved.

2. That the acceptance by the City Manager of a grant deed of EGGER & GHIO CO. INC., a California corporation, executed in favor of The City of San Diego, bearing date of January 17, 1986, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 266289 - 2, granting to said City a sewer pump station site in a portion of Lot 17 of Garden Villa Tract, as more particularly described in said deed, be, and the same is hereby approved.

3. That the acceptance by the City Manager of a sewer easement deed of EGGER & GHIO CO. INC., a California corporation, executed in favor of The City of San Diego, bearing date of January 17, 1986, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 266289 - 3, granting to


the City a sewer easement in a portion of Lot 17 of Garden Villa Tract, as more particularly described in said deed, be, and the same is hereby approved.

4. That the Mayor and the City Clerk are hereby authorized to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 266289 -4, quitclaiming to EGGER & GHIO CO. INC., a California corporation, an unneeded easement for a sewer line and sewer pumping station site in Lots 14, 15, 16 and 17 of Garden Villa Tract, as more particularly described in the quitclaim deed.

5. That the expenditure of an amount not to exceed \$27,000 from Capital Improvement Program 46.052.0, Palm City Trunk Sewer, to cover the cost of acquisition of the sewer easement, be, and the same is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk shall deliver the deeds and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
