BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an

agreement with the Adams Avenue Business Improvement Association, Inc., for the operation of the Adams Avenue Business Improvement District, for the one (1) year period July 1, 1986 through June 30, 1987, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No.
