WHEREAS, all claims are screened by highly trained medical examiners to determine if the service billed is a benefit covered by the Plan; if charges billed are usual, customary and reasonable; and if quality medical standards have been met; and

WHEREAS, the Foundation proposed a rate increase from \$6 to \$6.75 per month which is necessary to counteract increased operating costs; and

WHEREAS, it is now necessary and appropriate to amend the existing agreement to extend the term thereof for one year to June 30, 1987, to provide for a \$6.75 per eligible member per month fee, and to add an equal opportunity proviso; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a SEVENTH AMENDMENT TO AGREEMENT, for administrative services, to be provided by the San Diego Foundation for Medical Care, for the purpose of administering the San Diego CITYMED Health Plan, pursuant to the Seventh Amendment to Agreement and the basic Administrative Services Agreement, on file in the office of the

City Clerk as Document No. RR-266293 and Document No. 751567, respectively.
