WHEREAS, as part of its Flexible and Management Benefits Plans, the City is offering a health indemnity type dental insurance plan to its employees; and

WHEREAS, the agreement provides for City employees to choose their own dentist; and

WHEREAS, if the employee chooses a preferred provider organization (PPO) dentist, service costs are at a significant discount, and the Plan pays a higher percentage of the dental service costs; and

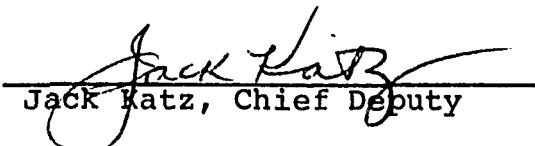
WHEREAS, monies have been budgeted in the FY 1987 Flexible Benefit Plan allotment within operating departments and in the FY 1987 Management Benefit Plan allotment in the Nondepartmental Budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with Standard Insurance Company, to provide health indemnity dental services, as an optional benefit in the Flexible and Management Benefits Plans, for a one-year period commencing

August 1, 1986, pursuant to the terms and conditions of the  
agreement for such services, on file in the office of the City  
Clerk as Document No. RR- 266300.
