

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$13,790.00 from CIP 29.606.0 (Torrey Pines Golf Course Irrigation Study) is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.


