WHEREAS, it is alleged that since July, 1979 there have been 58 overflows from Sewer Pump Station No. 64 resulting in the discharge of millions of gallons of raw sewage into Penasquitos Lagoon; and

WHEREAS, it is alleged that Sewer Pump Station No. 64 is not operated and maintained in a manner that would provide reliable service and prevent sewage overflows; and

WHEREAS, the Regional Water Quality Control Board at its

June 16, 1986 meeting issued a Cease and Desist Order to The City

of San Diego to immediately stop sewage overflows into the

Penasquitos Lagoon; and

WHEREAS, the Regional Water Quality Control Board continues to monitor the operation of Sewer Pump Station No. 64 and the proposed improvements to said pump station; and

WHEREAS, the Council of The City of San Diego passed emergency ordinance No. O-16686 on July 14, 1986 to prohibit the issuance of any building permits which required a sewer hookup in the Sewer Pump Station No. 64 service area through and including July 29, 1986; and

WHEREAS, it is necessary to expeditiously expand the capacity of Pump Station 64 by the addition of two (2) new pumps with supporting equipment to insure the safe and reliable pumping of sewage through Pump Station 64; and

WHEREAS, the situation herein described constitutes an emergency and the City Council finds that it is necessary for the immediate preservation of the public peace, property, health and safety to waive the competitive bidding provisions of San Diego City Charter section 35; NOW, THEREFORE,

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$625,000 within the Sewer Revenue Fund (41506), from the Unallocated Reserve (70697) to the Metropolitan Wastewater Construction Program (70492), CIP No. 46-118.0 Pump Station 64 Force Main II, solely and exclusively for the purpose of funding these purchases.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$625,000 from the Metropolitan Wastewater Construction Fund (70492), CIP 46-118.0 Pump Station 64 Force Main II, is hereby authorized, solely and exclusively for the purpose of funding these purchases.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to negotiate for and behalf of

said City an agreement with Fairbanks - Morse, Inc. for pumps, motors, drive shaft and spare parts.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered to negotiate, for and behalf of said City, an agreement with Gould Pumps, Inc. for starters for said pumps.
