

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a memorandum of understanding with San Diego Gas and Electric Co., to provide alternate electric service to Pump Station No. 64, under the terms and conditions set forth in the Memorandum of Understanding on file in the office of the City Clerk as Document No. RR- 266310

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$64,479 within the Sewer Revenue Fund No. 41506 from the Unallocated Reserve (70697) to the Sewer Pump Station Maintenance Program (70450).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$64,479 from the Sewer Revenue Fund No. 41506, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.



BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to provide a letter of commitment for entering into special facilities agreement with San Diego Gas & Electric Co.
