WHEREAS, emergency storage facilities are needed at Sewer

Pump Station No. 64 to prevent sewage overflow spills; and

WHEREAS, in order to alleviate the sewage overflow problem

the project needs to be declared as a potential emergency; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager be and he is hereby authorized to declare Sewer Pump Station No. 64 as a potential emergency.
- 2. That Capital Improvement Program of the Sewer Revenue Fund No. 41506 is hereby amended by adding Capital Improvement Program No. 46-126, Sewer Pump Station No. 64 Emergency Storage.
- 3. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the construction of Sewer Pump Station No. 64 Emergency Storage, filed in the office of the City Clerk of The City of San Diego, California, on

JUL 28 1986, and bearing official Document No. No. 170311 be and the same are hereby approved.

4. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

- 5. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the construction of Sewer Pump Station No. 64 Emergency Storage.
- 6. That the City Auditor and Comptroller is hereby authorized to transfer \$1,018,061 within the sewer Revenue Fund No. 41506 from the Unallocated Reserve (70697) to the Sewer Main Construction Program (70492).
- 7. That the expenditure, not to exceed \$1,018,061 from Sewer Revenue Fund 41506 (CIP 46-126) is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
