BE IT RESOLVED, by the Council of The City of San Diego, that in connection with the proposed land exchange with Genstar Development, Inc., it is the intention of this City Council to

1. Dedicate as park land, pursuant to the City Charter, the 291 acres received from Genstar as a part of the Los Penasquitos Canyon Preserve; and
2. Cause the approximately \$1 million received from the transaction to be set aside and utilized solely for the maintenance and enhancement of the Preserve;
3. Limit any improvements on the 291 acres to those directly related to park use; and
4. In the approval of any permits for the development of the City land being exchanged, require the dedication of all necessary rights of way, including but not necessarily limited to those necessary for the widening of Interstate 5 and the extension of the San Diego Trolley.

BE IT FURTHER RESOLVED, that the City Attorney be and he is hereby requested to prepare an impartial analysis of the measure on the November ballot pursuant to section 5011 of the California Elections Code.

BE IT FURTHER RESOLVED, that Council Policy 600-30 be waived with respect to the Genstar Development, Inc. deposit of \$40,000 and that the City Auditor be authorized to accept said late deposit.
