BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the balance of the contract with CAMERA MART is hereby cancelled for furnishing PHOTOGRAPHIC PROCESSING SERVICE, Schedule I (Color Film Processing) as may be required for a period of one (1) year beginning November 1, 1985 through October 31, 1986, as authorized by Resolution No. 264499, adopted November 25, 1985.
2. That the second low bid of ONE HOUR PHOTO STOP is hereby accepted and the City Manager is hereby authorized to execute a contract for PHOTOGRAPHIC PROCESSING SERVICE, Schedule I (Color Film Processing) as may be required for the period of July 1, 1986 through October 31, 1986, for a total estimated cost of \$7,380.83; terms net 20 days, with an option to renew contract for an additional one (1) year period.
