RESOLUTION NUMBER R-266337

ADOPTED ON AUGUST 4, 1986

WHEREAS, on May 5, 1986 the Council adopted a series of resolutions initiated by the office of Deputy Mayor Ed Struiksma to keep our coastline free of oil wells; and

WHEREAS, one of those resolutions included a November 1986 City Ballot Measure directing the City to use its powers to prevent offshore drilling within 100 nautical miles of our coastline; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Deputy Mayor Ed Struiksma, Councilmember Mike Gotch, the Sierra Club, CONVIS, Mayor and City Council, be and they are hereby authorized and empowered as proponents and signators, for and on behalf of said City, of the ballot argument in favor of the November 1986 measure regarding off-shore oil drilling.
