BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF WEST MIRAMAR SOLID WASTE DISPOSAL FACILITY PHASE I - CONTRACT 2, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on AUG 4 1986 and bearing official Document No. W.O. 118780 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF WEST MIRAMAR SOLID WASTE DISPOSAL FACILITY PHASE I - CONTRACT 2.
4. That the expenditure, not to exceed \$1,761,105 from CIP No. 37-055.4 WEST MIRAMAR REFUSE DISPOSAL FACILITY - PHASE I, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the Administering Department, to transfer excess budgeted funds, if any, to the appropriate reserves.
