ADOPTED ON AUG 4 1986

WHEREAS, in Closed Session on July 29, 1986, the City Council, by the following vote: Yeas, Districts 2, 3, 6, 8 and the Mayor; Nays, None; Not Present, Districts 1, 4, 5 and 7; approved the following; and

WHEREAS, pursuant to Resolution No. 259584 and Superior Court Case No. 516902, the City of San Diego has previously deposited the sum of \$196,000.00 as the probable compensation to be awarded for the condemnation of Parcel No. 2;

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to pay the additional sum of \$30,000.00 towards the settlement of City of San Diego v. Isenhour, et al. Parcel No. 2 Superior Court Case NO. 516902.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to expend the amount of \$30,000.00 from Fund 79104, Open Space, payable to Eleanor Brown, Robert Pastore, Roy Ledford, Jr., Anne Evans, Lucille Green, and San Diego Trust and Savings Bank; and Joyce McCoy, their attorney of record, as the final payment towards full settlement of the lawsuit and all claims.
